CABINET DECISION NO. 3280 DATED 11.12.2025

Subject: Reorganization of 11 Revenue Districts into 13 Revenue Districts – making the districts co-terminus with MCD Zones, NDMC and Delhi Cantonment Board.

Decision: The Council of Ministers considered the proposal of Revenue Department and approved the proposals contained in Para – 6 [1 to 5] of the Cabinet Note with the following observations:-

- a) Transfer of all relevant data and physical/electronic records should be done expeditiously.
- b) Data and records should be updated with complete digitization of records.
- c) District Headquarters should be established at centrally accessible locations within the respective districts for convenience of general public.
